In preparation for the survey to be run again in Autumn 2007 and be mailed to a national sample of approximately 142,000 patients (i.e. 850 recent inpatients for each the 167 applicable English Acute Hospital Trusts with sufficient inpatient beds), the amendment sought approval for the addition of 6 new questions to the core questionnaire.

The Committee had no ethical difficulties with the proposed changes.

The members of the Committee present gave a favourable ethical opinion of the amendment on the basis described in the notice of amendment form and supporting documentation.
