The above amendment was reviewed at the meeting of the Sub-Committee held on 13 March 2012.

#### Ethical opinion

The amendment requested approval to repeat the accident & emergency departments survey in 2012. Minor modifications had been made to the content of the survey and recruitment documentation since the survey was last conducted in 2008. It was also proposed to pilot an online version of the survey across five trusts to test whether or not it would be a viable method of data collection. In addition the amendment informed the REC that there had been a change of Chief Investigator from Dr Caroline Powell to Mr Chris Graham.

A clear and comprehensive rationale had been submitted in support of the amendment.

The Sub-Committee identified no ethical issues with the proposed amendment.

The members of the Committee taking part in the review gave a favourable ethical opinion of the amendment on the basis described in the notice of amendment form and supporting documentation.
