Accident and Emergency Department Survey 2012

To improve the quality of services that the NHS delivers, it is important to understand what patients think about their care and treatment. One way of doing this is by asking patients who have recently used their local health services to tell us about their experiences.

The results of surveys are mainly for NHS trusts to use to help them improve their performance. CQC has included data from this survey in the Quality and Risk Profile (QRP) for each provider. The QRP contributes to our assessment of providers' compliance with the essential standards of quality and safety set by the Government. The Department of Health will also use the results for performance assessment, improvement and regulatory purposes.

The fourth survey of accident and emergency (A&E) patients involved 147 acute and specialist NHS trusts with a major accident and emergency department. We received responses from nearly 46,000 patients, which is a response rate of 38%. Patients were eligible to take part in the survey if they were aged 16 years or older, were not hospital inpatients at the time of the survey, and if they attended A&E in January, February or March 2012 (sampling month chosen by the trust). Women who had attended A&E primarily to obtain contraception, who suffered a miscarriage or another form of abortive pregnancy outcome while at the hospital, and patients

¹ Trusts were eligible to participate if they had a major or consultant led 24 hour service with full resuscitation facilities and designated accommodation for the reception of accident and emergency patients.

with a concealed pregnancy were not included in this survey. Survey fieldwork took place between May and September 2012.

Similar surveys of A&E departments were also carried out in 2003, 2004 and 2008. They are part of a wider programme of NHS patient surveys, which covers a range of topics including mental health services, adult inpatient and adult outpatient services. The tables in this report show national results for A&E surveys carried out in 2004 and 2008. Results from 2003 can be found on the survey Coordination Centre website here: www.nhssurveys.org/surveys/29

Interpreting the tables

The tables present the national results for each question asked in 2012, and in 2004 and 2008, where comparable.² The survey years are shown across the top of the table, with the responses for each question down the side. The bottom row shows the 'number of respondents,' that is the number of people that the results are based on.

The tables show all specific responses to a question. Responses such as "don't know" or "can't remember" are not shown, as these do not help evaluate performance.

The tables present percentage figures rounded to the nearest whole number, so the values given for any question will not always add up to 100%.

Where the columns for 2004 or 2008 are missing, this means that we cannot compare the results, either because the question was not asked previously, or because the question wording and/or the response categories have been changed. As a consequence, the results are no longer comparable because we do not know if any change is caused by alterations in the survey itself or by variation in service performance.

² The results from each trust are given equal weight in calculating the England (national) results. Some trusts have a higher response rate than others and would therefore have a greater influence over the England (national) average. To correct this we apply a 'weight' to the data. As a result of applying this weight, the responses from each trust have an equal influence over the England average, regardless of differences in response rates between trusts.

Notes on specific questions

Due to errors generating questionnaires, results are excluded for the following questions:

Q10, Q32 and Q51: Brighton and Sussex University Hospitals NHS Trust

Q16 and Q43: Calderdale and Huddersfield NHS Foundation Trust

Q28: University Hospitals of Leicester NHS Trust

For Q36, data from two trusts have been excluded as there were less than 30 responses.

Filter questions

Not all of the questions in the survey were to be answered by everybody. Some questions are not applicable to everyone: for example, if a respondent did not travel to hospital in an ambulance (Q3), then they skip Q4 and Q5 as they are not relevant to them.

Statistical significance

We carried out statistical tests on the data to determine whether there had been any statistically significant changes in the results for 2012 compared with the surveys carried out in 2008 and 2004.³ A statistically significant difference means that the change in the results is very unlikely to have occurred by chance. The final columns of the tables use 'up' and 'down' arrows to indicate whether there has been a 'statistically significant' change.

↑ shows that there has been a statistically significant increase in results ↓ shows that there has been a statistically significant decrease in results.

Where a cell in the final two columns is blank, there has been no statistically significant change.

For example, in the table for question 19, we can see that there has been a statistically significant increase in the proportion of respondents who said that they were 'definitely' given enough privacy when being examined or treated in the A&E department - as indicated by an 'up' arrow. There have been corresponding

³ We used z-tests of the column proportions using the Bonferroni method to correct for multiple comparisons only (for questions with three years of comparable data).

decreases in the proportion responding 'to some extent' and 'no' - as indicated by a 'down' arrows.

In some of the tables, the arrows suggest that there has been a significant change but the results look the same. An example of this can be seen for question 8 where the proportions of respondents who say that they waited 'more than 1 hour but no more than 2 hours' before being examined by a doctor or nurse is the same in 2008 and 2012, yet there are arrows indicating a significant change. This is because results presented in the tables have been rounded up or down to a whole number. If the results were presented to a number of decimal places, a small difference could be seen. Some of the changes in the survey results are very small, but because of the large number of respondents that took part, they are statistically significant.
