Ethical opinion

Approval was sought for an amended, 2022 version of the study with adjustments to the questionnaire and the sampling variables. The amendments were minor and were largely to accommodate on-going changes to the delivery of care associated with the pandemic and organisational changes in the NHS. The documents reviewed are noted below.

The documents and the changes raise no ethical issues which are not reasonably handled and justified in the application documents. For the sake of completeness, it would be useful to see the final Confidentiality Advisory Group letter when it arrives. Overall, it is good to see that the process continues to be reflective and critical in each iteration, and that previous discussions about ethical issues have been revisited. I am happy to give a favourable ethical opinion of the study on the basis described in the Ethics Application form and supporting documentation.

Committee Process

The CQC's Independent Ethics Review Panel is tasked with reviewing studies commissioned by the CQC. It is chaired by Dr Mark Sheehan and includes Nigel Booth (Lay member) and Dr Gary Abel (Statistician).
