Study title: Community Mental Health Survey 2022 (CMH22) Date submitted: 22nd November 2021

Ethical opinion

Approval was sought for an amended, 2022 version of the study with adjustments to the questionnaire and the documentation. Many of the amendments were minor and were largely to accommodate the on-going changes to the delivery of care associated with the continuing impact of the pandemic on service provision. There was a particular focus on the ways in which these changes impacted the form of care and wating times. The documents reviewed are noted below.

The documents and the changes raise no ethical issues which are not reasonably handled and justified in the application documents. I am happy to give a favourable ethical opinion of the study on the basis described in the Ethics Application form and supporting documentation.

In particular, I note that the survey coordination team have again considered the question of directing respondents to an independent organisation in cases where there might be safeguarding concerns. I agree that because the invitation letters are written from the perspective of the Trust providing care, having reference to a third-party may cause unnecessary concern. However, it would be helpful if, as they suggest, the team could consider alternate locations for such a link – perhaps alongside the free text question in the survey itself. Overall, though, that the safeguarding processes are thorough and robust.

Committee Process

The CQC's Independent Ethics Review Panel is tasked with reviewing studies commissioned by the CQC. It is chaired by Dr Mark Sheehan and includes Nigel Booth (Lay member) and Dr Gary Abel (Statistician). In accordance with its operating procedures, the full Panel reviews research studies which are new and have not been reviewed by the panel or its precursor. Amended, updated, or previously reviewed research studies are reviewed by the Chair.
